This acknowledgement is based on your signing the Fireplace Partnership Agreement, our review of the report from Myren Consulting Test Laboratories submitted to EPA, dated March 5, 2010, and the submittal of an appropriate Owner's Manual that covers operation of the fireplace with the catalyst. EPA recommends that the catalyst be replaced every 3 to 5 years in this fireplace. The test reports indicates that this fireplace has an average emissions level of 4.8 grams of fine particles per kilogram of wood burned. This emission level is below the qualifying Phase 2 emission level of 5.1 g/kg.
