

- Do not store or use gasoline or other flammable vapors and liquids in the vicinity of this or any other appliance.
- WHAT TO DO IF YOU SMELL GAS
 - Do not try to light any appliance.
 - Do not touch any electrical switch; do not use any phone in your building.
 - Immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions.
 - If you cannot reach your gas supplier, call the fire department.
- Installation and service must be performed by a qualified installer, service agency or the gas supplier.

A WARNING: Carefully review the instructions supplied with the decorative type unvented room heater for the minimum fireplace size requirement.

DO NOT INSTALL THE APPLIANCE IN THIS FIREBOX, UNLESS THIS FIREBOX MEETS THE MINIMUM DIMEN-SIONS REQUIRED FOR THE INSTALLATION.

A WARNING: FOR USE ONLY WITH A LISTED, GAS-FIRED UNVENTED DECORATIVE ROOM HEATER NOT TO EXCEED 40,000 BTU/H.

DO NOT BUILD A WOOD FIRE.

SAFETY

This appliance may be installed in an aftermarket,* permanently located, manufactured (mobile) home, where not prohibited by local codes.

* Aftermarket: Completion of sale, not for purpose of resale, from the manufacturer

This firebox has been tested under Z21.91b-2007 for use with approved ANSI Z21.11.2 decorative type unvented room heater. IMPORTANT: Read this owner's manual carefully and completely before trying to assemble, operate or service this fireplace. Improper use of this fireplace can cause serious injury or death from burns, fire, explosion, electrical shock and carbon monoxide poisoning.

A DANGER: Carbon monoxide poisoning may lead to death!

SAFETY

WARNING: Any change to this firebox or its controls can be dangerous.

WARNING: Do not allow fans to blow directly into the firebox. Avoid any drafts that alter burner flame patterns. Ceiling fans can create drafts that alter burner flame patterns. Altered burner patterns can cause sooting.

WARNING: Do not use a blower insert, heat exchanger insert or other accessory not approved for use with this firebox.

Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

Do not place clothing or other flammable material on or near the appliance. Never place any objects in the firebox or on logs.

Firebox front and screen becomes very hot when running firebox. Keep children and adults away from hot surfaces to avoid burns or clothing ignition. Firebox will remain hot for a time after shutdown. Allow surfaces to cool before touching.

Carefully supervise young children when they are in the room with firebox.

Keep the fireplace area clear and free from combustible materials, gasoline, and other flammable vapors and liquids.

You must operate this fireplace with the provided fireplace screen and hood in place. Make sure these parts are in place and screens are closed before running installed gas log heater. Replace hood with FMI PRODUCTS, LLC model 109511-01 50", 109511-02 42", or 109511-03 36" only. This hood has been designed to keep the operation of your fireplace safe and efficient.

- 1. Do not use this firebox as a wood burning fireplace. Use only decorative unvented room heaters (log sets).
- Do not add extra logs or ornaments such as pine cones, vermiculite or rock wool. Using these added items can cause sooting.
- Use only the provided hood. See <u>Parts</u>, page 30.
- Vent-free gas log heaters installed in these fireboxes require fresh air ventilation to run properly. See <u>Air for Combustion and</u> <u>Ventilation</u>, page 8.
- 5. Do not run vent-free heaters installed in these fireboxes
 - where flammable liquids or vapors are used or stored
 - under dusty conditions
- 6. Do not use this firebox to cook food or burn paper or other objects.
- Turn unit off and let cool before servicing. Only a qualified service person should service and repair firebox.
- 8. Operating vent-free heaters installed in these fireboxes above elevations of 4,500 feet could cause pilot outage.
- 9. Do not use the firebox if it has been under water.
- 10. Before using furniture polish, wax, carpet cleaner or similar products, turn heater off. If heated, the vapors from these products may create a white powder residue within burner box or on adjacent walls and furniture.
- 11. Provide adequate clearances around air openings.

LOCAL CODES

Install and use firebox with care. Follow all local codes. In the absence of local codes, use the latest edition of *The National Fuel Gas Code ANSI Z223.1/NFPA 54**. Firebox must be electrically grounded in accordance with the *National Electrical Code, ANSI/NFPA70* (latest edition).

PRODUCT FEATURES

OPERATION

This firebox is designed for use with approved ANSI Z21.11.2 decorative type unvented room heaters. (Physical size limitations apply. Refer to minimum firebox requirements supplied with log heater.) It requires no outside venting or chimney making installation easy and inexpensive. State of Massachusetts: The installation must be made by a licensed plumber or gas fitter in the Commonwealth of Massachusetts.

Sellers of unvented propane or natural gas-fired supplemental room heaters shall provide to each purchaser a copy of 527 CMR 30 upon sale of the unit.

Vent-free gas products are prohibited for bedroom and bathroom installation in the Commonwealth of Massachusetts.

LOCATING FIREBOX


PLANNING

Plan where you will install the firebox. This will save time and money later when you install the firebox. Before installation, consider the following:

- Where firebox will be located. Allow for wall and ceiling clearances (see <u>Installa-</u> <u>tion Clearances</u>, page 11).
- 2. Everything needed to complete installation.
- These models CANNOT be installed in a bedroom unless maximum Btu rating of installed vent-free log set is less than 10,000 Btu/hr.
- Proper air for combustion and ventilation (page 8).




Figure 1 - 36" Models (V)U36(H,S) and (V)Q36(H,S)(R) Series (Picture may vary from actual fireplace)




Figure 2 - 42" Models (V)U42(H,S) and (V)Q42(H,S)(R) Series (Picture may vary from actual fireplace)




Figure 3 - 50" Models (V)U50(H,S) AND (V)Q50(H,S)(R) Series (Picture may vary from actual fireplace)

AIR FOR COMBUSTION AND VENTILATION

WARNING: This heater shall not be installed in a room or space unless the required volume of indoor combustion air is provided by the method described in the *National Fuel Gas Code, ANSI Z223.1/NFPA54*, the *International Fuel Gas Code,* or applicable local codes. Read the following instructions to insure proper fresh air for this and other fuel-burning appliances in your home.

Today's homes are built more energy efficient than ever. New materials, increased insulation and new construction methods help reduce heat loss in homes. Home owners weather strip and caulk around windows and doors to keep the cold air out and the warm air in. During heating months, home owners want their homes as airtight as possible.

While it is good to make your home energy efficient, your home ne eds to breathe. Fresh air must enter your home. All fuel-burning appliances need fresh air for proper combustion and ventilation.

Exhaust fans, fireplaces, clothes dryers and fuel burning appliances draw air from the house to operate. You must provide adequate fresh air for these appliances. This will insure proper venting of vented fuel-burning appliances.

PROVIDING ADEQUATE VENTILATION

The following are excerpts from National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation.

All spaces in homes fall into one of the three following ventilation classifications:

- 1. Unusually Tight Construction
- 2. Unconfined Space
- 3. Confined Space

The information on pages 8 through 10 will help you classify your space and provide adequate ventilation.

Unusually Tight Construction

The air that leaks around doors and windows may provide enough fresh air for combustion and ventilation. However, in buildings of unusually tight construction, you must provide additional fresh air. Unusually tight construction is defined as construction where:

- a. walls and ceilings exposed to the outside atmosphere have a continuous water vapor retarder with a rating of one perm (6 x 10⁻¹¹ kg per pa-sec-m²) or less with openings gasketed or sealed <u>and</u>
- b. weather stripping has been added on openable windows and doors <u>and</u>
- c. caulking or sealants are applied to areas such as joints around window and door frames, between sole plates and floors, between wall-ceiling joints, between wall panels, at penetrations for plumbing, electrical and gas lines and at other openings.

If your home meets all of the three criteria above, you must provide additional fresh air. See <u>Ventilation Air From Outdoors</u>, page 10.

If your home does not meet all of the three criteria above, proceed to <u>Determining</u> <u>Fresh-Air Flow For Firebox Location</u>.

Confined and Unconfined Space

The National Fuel Gas Code, ANSI Z223.1/ NFPA 54 defines a confined space as a space whose volume is less than 50 cubic feet per 1,000 Btu per hour (4.8 m³ per kw) of the aggregate input rating of all appliances installed in that space and an unconfined space as a space whose volume is not less than 50 cubic feet per 1,000 Btu per hour (4.8 m³ per kw) of the aggregate input rating of all appliances installed in that space. Rooms communicating directly with the space in which the appliances are installed*, through openings not furnished with doors, are considered a part of the unconfined space.

* Adjoining rooms are communicating only if there are doorless passageways or ventilation grills between them.

DETERMINING FRESH-AIR FLOW FOR FIREBOX LOCATION

Determining if You Have a Confined or Unconfined Space

Use this work sheet to determine if you have a confined or unconfined space.

Space: Includes the room in which you will install heater plus any adjoining rooms with doorless passageways or ventilation grills between the rooms.

AIR FOR COMBUSTION AND VENTILATION Continued

1. Determine the volume of the space (length x width x height).

Length x Width x Height = _____cu. ft. (volume of space)

Example: Space size 22 ft. (length) x 18 ft. (width) x 8 ft. (ceiling height) = 3,168 cu. ft. (volume of space)

If additional ventilation to adjoining room is supplied with grills or openings, add the volume of these rooms to the total volume of the space.

2. Multiply the space volume by 20 to determine the maximum Btu/Hr the space can support.

_____(volume of space) x 20 = (Maximum Btu/Hr the space can support) *Example*: 3,168 cu. ft. (volume of space) x 20 = 63,360 (maximum Btu/Hr space can support)

 Add the Btu/Hr of all fuel burning appliances in the space.

 Btu/Hr
 Btu/Hr

* Do not include direct-vent gas appliances. Direct-vent draws combustion air from the outdoors and vents to the outdoors.

Example:

Gas water heater	40,000	_Btu/Hr
Vent-free fireplace	+ 39,000	_Btu/Hr
Total	= 79,000	_Btu/Hr

 Compare the maximum Btu/Hr the space can support with the actual amount of Btu/Hr used.

_____ Btu/Hr (maximum the space can support)

_____ Btu/Hr (actual amount of Btu/Hr used)

Example: 63,360 Btu/Hr (maximum the space can support)

79,000 Btu/Hr (actual amount of Btu/Hr used)

The space in the example is a confined space because the actual Btu/Hr used is more than the maximum Btu/Hr the space can support. You must provide additional fresh air. Your options are as follows:

- A. Rework worksheet, adding the space of an adjoining room. If the extra space provides an unconfined space, remove door to adjoining room or add ventilation grills between rooms. See <u>Ventilation Air From Inside Building</u>.
- B. Vent room directly to the outdoors. See <u>Ventilation Air From Outdoors</u>, page 10.
- C. Install a lower Btu/Hr fireplace, if lower Btu/ Hr size makes room unconfined.

If the actual Btu/Hr used is less than the maximum Btu/Hr the space can support, the space is an unconfined space. You will need no additional fresh air ventilation.

WARNING: If the area in which the heater may be operated does not meet the required volume for indoor combustion air, combustion and ventilation air shall be provided by one of the methods described in the National Fuel Gas Code, ANSI Z223. 1/NFPA 54, the International Fuel Gas Code, or applicable local codes.

VENTILATION AIR

Ventilation Air From Inside Building

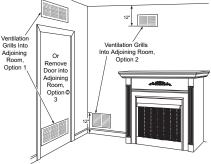


Figure 4 - Ventilation Air from Inside Building

This fresh air would come from an adjoining unconfined space. When ventilating to an adjoining unconfined space, you must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor on the wall connecting the two spaces (see options 1 and 2, Figure 4). You can also remove door into adjoining room (see option 3, Figure 4). Follow the National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation for required size of ventilation grills or ducts.

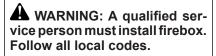
AIR FOR COMBUSTION AND VENTILATION

Continued

Ventilation Air From Outdoors

Provide extra fresh air by using ventilation grills or ducts. You must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor. Connect these items directly to the outdoors or spaces open to the outdoors. These spaces include attics and crawl spaces. Follow the National Fuel Gas Code, ANSI Z223.1/NFPA 54, Air for Combustion and Ventilation for required size of ventilation grills or ducts.

IMPORTANT: Do not provide openings for inlet or outlet air into attic if attic has a thermostat-controlled power vent. Heated air entering the attic will activate the power vent.



WARNING: Never install firebox

- in a bedroom or bathroom*
- in a recreational vehicle
- where curtains, furniture, clothing, or other flammable objects are less than 36" from front or 42" from top of firebox; for side clearances see Figure 4, page 11
- · in high traffic areas
- · in windy or drafty areas

* Unless installed log set is rated at 10,000 Btu/Hr or less.

CAUTION: Log heaters installed in this firebox create warm air currents. These currents move heat to wall surfaces next to firebox. Installing firebox next to vinyl or cloth wall coverings or operating firebox where impurities (such as, but not limited to, tobacco smoke, aromatic candles, cleaning fluids, oil or kerosene lamps, etc.) in the air exist, may discolor walls or cause odors.

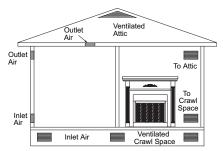


Figure 5 - Ventilation Air from Outdoors

INSTALLATION

NOTICE: The firebox identification label (including model number, serial number, clearances, etc.) is located on a chain under the bottom refractory.

IMPORTANT: Vent-free gas log heaters add moisture to the air. Although this is beneficial, installing firebox in rooms without enough ventilation air may cause mildew to form from too much moisture. See, page 8.

IMPORTANT: Make sure the firebox is level. If firebox is not level, log set will not work properly.

Note: Your firebox is designed to be used in zero clearance installations. Wall or framing material can be placed against any exterior surface on the rear, sides, top or bottom of your firebox, except where standoff spacers are integrally attached. If standoff spacers are attached to your firebox, these spacers can be placed directly against wall or framing materials. Use the dimensions shown for rough opening to create the easiest installation.

Use dimensions shown for rough openings to create the easiest installation (see *Built-In Firebox Installation*, page 12).

INSTALLATION CLEARANCES

WARNING: Maintain the minimum clearances. If you can, provide greater clearances from floor, ceiling, and adjoining wall.

Carefully follow the instructions below. This will ensure safe installation.

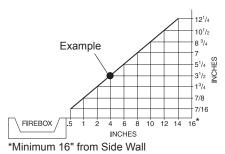


Figure 6 - Minimum Clearance for Combustible to Wall

Minimum Wall and Ceiling Clearances (see Figure 6)

- A. Clearances from the side of the fireplace cabinet to any combustible material and wall should follow diagram in Figure 6. *Example:* The face of a mantel, bookshelf, etc. is made of combustible material and protrudes 3 ¹/₂" from the wall. This combustible material must be 4" from the side of the fireplace cabinet (see Figure 4).
- B. Clearances from the top of the firebox opening to the ceiling should not be less than 42".
- C. When the firebox is installed directly on carpeting, tile or other combustible material, other than wood flooring, the firebox should be installed on a metal or wood panel extending the full width and depth of the enclosure.
- D. Clearances from the bottom of firebox to the floor is 0".

These fireboxes can be installed as freestanding units against a wall with approved cabinet mantels that may be available from your retailer or supplier, or as a built-in unit. The clearances are the same for either installation method.

Mantel Clearances for Built-In Installation




Figure 7 - Minimum Mantel Clearances for Built-In Installation

If placing custom mantel above built-in firebox, you must meet the minimum allowable clearance between mantel shelf and top of firebox opening shown in Figure 7. These are the minimum allowable mantel clearances for a safe installation. Use larger clearances wherever possible to minimize the heating of objects and materials placed on the mantel.

A CAUTION: Do not allow the vent-free gas log heater to touch or extend beyond the fireplace screen.

NOTICE: Surface temperatures of adjacent walls and mantels become hot during operation. Walls and mantels above the firebox may become hot to the touch. If installed properly, these temperatures meet the requirement of the national product standard. Follow all minimum clearances shown in this manual.

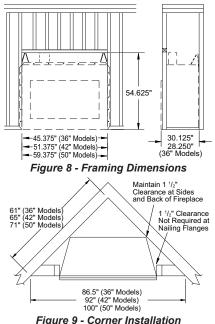
NOTICE: If your installation does not meet the minimum clearances shown, you must do one of the following:

- raise the mantel to an acceptable height
- remove the mantel

BUILT-IN FIREBOX INSTALLATION

Built-in installation of this firebox involves installing firebox into a framed-in enclosure. This makes the front of firebox flush with wall. If installing a mantel above the firebox, you must follow the clearances shown in Figure 7, page 11. Follow these instructions to install the firebox in this manner.

- Frame in rough opening. The firebox framing should be constructed of 2 x 4 lumber or heavier. Use dimensions and rough opening layout in Figure 8. Adjust framing so that firebox flushes with finished wall surface. If installing in a corner, use dimensions in Figure 9, for rough opening.
- Install gas piping to firebox location. See <u>Installing Gas Line</u> on page 14 and <u>Con-</u> <u>necting to Gas Supply</u> in log set owner's manual.

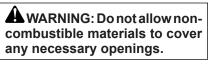



- Carefully set firebox in front of rough opening with back of firebox inside wall opening.
- 4. Carefully insert firebox into rough opening.
- Attach firebox to wall studs using nails or wood screws through holes in nailing flange (see Figure 10).
- Install and properly test gas log heater. Follow installation instructions included with the vent-free gas log heater that is being installed.

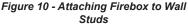
IMPORTANT: When finishing your firebox, combustible materials such as wall board, gypsum board, sheet rock, drywall, plywood, etc. may be butted up next to the sides and top of the firebox. Combustible materials should never overlap the firebox front facing.

WARNING: Do not allow any combustible materials to overlap the firebox front facing.

IMPORTANT: Noncombustible materials such as brick, tile, etc. may overlap the front facing, but should never cover any necessary openings.







INSTALLATION

WARNING: Use only noncombustible mortar or adhesives when overlapping the front facing with noncombustible facing material.

INSTALLING FIREBOX USING OPTIONAL CUSTOM BUILT MANTELS

WARNING: A qualified service person must install firebox. Follow all local codes.

This firebox may be installed using a cabinet mantel against a wall in your home. The firebox and cabinet mantel can be installed directly on the floor. Mantels may be available from your retailer or custom built for your home.

- 1. Assemble cabinet mantel as instructed.




Figure 11 - Installing Cabinet Mantel (Mantel May Vary From Illustration)

- Install gas piping to firebox location. See <u>Installing Gas Line</u>, page 14. You may have to cut an access hole in the floor or wall to run gas line to firebox. Make sure to locate access hole so cabinet mantel will cover it when installed (see Figure 11).
- Place firebox on floor in desired location. Make sure mantel will be flush against wall when installed.

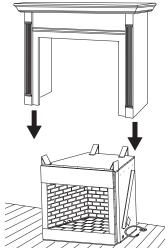


Figure 12 - Inserting Firebox Into Cabinet Mantel (Mantel May Vary From Illustration)

- Carefully slide cabinet mantel over firebox. Be careful not to scratch firebox, cabinet mantel, flooring, etc., when installing (see Figure 12).
- Install and properly test gas log heater. Follow installation instructions included with the vent-free gas log heater that is being installed.

REFRACTORY PANEL INSTALLATION

IMPORTANT: Installation of brick should be done after the fireplace is placed in a permanent location.

- Remove screen assemblies and all hardware components out of the firebox. The bottom panel is preinstalled in the firebox. Make sure the bottom refractory panels is centered in the firebox and flush with the front of the fireplace.
- Place cardboard on top of bottom refactory panel as a protection to prevent shipping and scratching during installation of the other panels.
- 3. Install rear refractory panel. This panel has a top and bottom. To determine which is which, match up the pattern on the rear panel with the left and right sides before installing the rear panel. Make sure panel is center before continuing.
- Install the right and left refractory panels with the gas line knockouts orientated down toward the bottom refractory. Align the left and right panels with the rear panel so the grout lines line up.





Figure 13 - Installing Refractory Panels

- Install the upper corner brackets and tighten set screws (Figure 13).

REFRACTORY PANEL INSTALLATION

INSTALLING SCREEN

- Slide round end of screen rod into rings at top of screen. Attach one push-on nut to end of rod before attaching last ring of screen.
- Insert the round end screen rod into hole on the left and right side of smoke shelf (Figure 14).
- Mount flat end of screen rod with #10 x 5/8" to center of smoke shelf.
- 4. Install other screen rod in same manner.



OPTIONAL GAS LINE INSTALLATION

Gas line hook up should be done by your supplier or a qualified service person.

Note: Before you proceed, make sure your gas supply is turned off.

Use only a 1/2" black iron pipe and appropriate fittings.

- Remove knockout indentation on refractory or firebrick wall located above refractory hearth floor. Knockout indentation must be firmly tapped with any solid object such as a 1/2" dowel until it is released. Remove fragmented portions of refractory (see Figure 15).
- Remove gas line cover plate located on either side of fireplace and pull out insulation from gas line conduit sleeve. Save insulation for reuse. Replace screws.




Figure 16 - Gas Line Installation

- Run a 1/2" black iron gas line into fireplace through the rear at gas line conduit sleeve (if using a raised platform, add height). Provide sufficient gas line into fireplace chamber for fitting connection (see Figure 16).

Note: Secure incoming gas line to wood framing to provide rigidity for threaded end.

 Repack insulation around gas line and into sleeve opening. Seal any gaps between gas line and refractory knockout hole with refractory cement or commercial furnace cement, Install the gas appliance or cap-off gas line if desired.

OPTIONAL GAS LINE INSTALLATION

Continued

A CAUTION: All gas piping and connections must be tested for leaks after the installation is completed. After ensuring that the gas valve is on, apply soap and water solution to all connections and joints. Bubbles forming show a leak. Correct all leaks at once. DO NOT USE AN OPEN FLAME FOR LEAK TESTING AND DO NOT OPER-ATE ANY APPLIANCE IF A LEAK IS DETECTED. LEAK TESTING SHOULD BE DONE BY A QUALI-FIED SERVICE PERSON.

WARNING: Do not operate an unvented gas log set in this fireplace with the chimney removed.

A gas line or gas log lighter may be installed for the purpose of installing a vented or ventfree decorative gas appliance incorporating an automatic shutoff device and complying with the Standard for Decorative Gas Appliances for Installation in Vented Fireplaces, ANSI Z21.60 or American Gas Association draft requirements for Gas Fired Log Lighters for Wood Burning Fireplaces, Draft NO. 4 dated August, 1993. If you install a decorative gas appliance (vented gas log), the decorative gas appliance must comply with the *Standard for Decorative Gas Appliance for Installation in Solid Fuel Burning Fireplaces, ANS Z21.60 or Z21.84* and shall also be installed in accordance with the *National Fuel Gas Code, ANSI 7223NFPA 54 latest edition.*

If you wish to install an unvented (vent-free) gas log set, only unvented gas log sets which have been found to comply with the standard for unvented room heaters, ANSI Z21.11.2 are to be installed in this fireplace.

WARNING: If the fireplace has been used for wood burning, the firebox and chimney must be cleaned of soot, creosote and ashes be a qualified chimney cleaner. Creosote will ignite if heavily heated.

WARNING: When using a decorative vented gas log, the damper must be removed or permanently locked in the fully open position and the glass doors must be in the fully open position.


REPLACEMENT PARTS






OPTIONAL OUTSIDE AIR KIT FOR FLOOR INSTALLATION - AK4F


